



**15th WT MRD Commission Meeting (via conference call)
December 2, 2021 | 14h00-15h00 (KST)**

1. Welcoming Remarks

The CHAIR warmly welcomed new members of the commission.

2. Introduction

All members made a brief introduction of themselves.

Mr. Jeongkang Seo explained the terms of references of the Commission.

3. Discussion

- a. Update of the membership status
 - Mr. Jeongkang Seo presented the overview of the current WT Membership system which is divided into the membership fee tier (I, II and III), the level (I and II) and the membership status (full, suspended and provisional).
- b. Restoration of membership: Paraguay Taekwondo Federation
 - Mr. Jeongkang Seo reported to the Commission the status and history of Paraguay Taekwondo Federation which has been suspended by WT for over 3 years.
 - The CHAIR remarked that Pan American Taekwondo Union has been closely monitoring the progress of the new leadership of Paraguay Taekwondo Federation and found it appropriate to recommend to the Council for reinstatement of the membership.
 - The Commission unanimously agreed to recommend to the Council the restoration of the membership of Paraguay Taekwondo Federation.
- c. MNA Membership Tier
 - Mr. Jeongkang Seo presented the current MNA Membership Tiers, and proposed shifting the tier of Ecuador and Lebanon for the next 2 years.
 - The CHAIR opened the floor and there were remarks as follows.
 - Invite CUs to evaluate the financial capacities of the MNAs for more practical and realistic list.
 - Continue recognizing the economic factors published by UN and also work with GMS to identify active / inactive MNAs to reflect the assessment in determination of the tier.
 - Initiate education of the MNA Presidents for effective management of the pertinent MNA and compliance with the requirements of WT.
 - Mr. Jeongkang Seo confirmed that MNA education program is under way and suggested that WT share the current Tier list with CUs for their feedbacks and contact GMS to start working for the assessment process.
